DRIVING AT LAKE PERKOLILLI RED DUST REVIVAL 2019

If you are to be a car entrant at The Red Dust Revival 19 you will need to hold a CAMS Driver's Licence, minimum level 2 speed, as the event will be insured by CAMS and thus run under their rules.

If you are from outside Australia and hold a motor-sport competition licence from another FIA-affiliated authority, you will need to get it accredited by CAMS by using the CAMS form "Foreign Participation in National Events Visa 2019" available on the Confederation of Australian Motor Sport (CAMS).

If you are from outside Australia and don't hold a motor-sport competition licence already you will need to proceed as below:

If you are in Australia and don't hold a motor-sport competition licence, but belong to a CAMS-affiliated Club, then apply though your Club for a CAMS level 2 licence, either long-term (L2S) or for the 30-day licence (L2SE) ensuring that it will be valid for a period including this event dates (11 - 17 September 2019).

If you don't hold a motor-sport competition licence, and don't belong to a CAMS-affiliated Club, whether you're in Australia or not, we can arrange temporary membership of The Vintage Sports Car Club of Western Australia (Inc), (cost \$50.00) which you will need before filling out a copy of CAMS form "Speed/Non-speed Licence Application/Renewal 2019". A copy of the Application for VSCCWA Membership is attached, and further copies, along with the CAMS Licence Application are available at the website www.motoringpast.com.au

Regardless of which of the above options you choose, you will need to fill out the "Health Statement" contained within the licence application. A "yes" (tick) to any of the six primary questions will require you to provide a communication from your Medical Practitioner stating that in their opinion your condition is under control and that you are fit to compete in this event. To assist your Practitioner in getting the letter right, it needs to be of the form "CAMS General Medical Condition Report" which is also attached and available on the above website.

If you want a twelve month licence, (\$140.00) and there's time to have it processed, then send it to CAMS at the address on the form.

If you are happy with just the 30 day (temporary) licence (\$95) DO NOT send it to CAMS:Instead:

Attach the membership receipt that you will get from the Club issuing temporary membership, or a photocopy of your membership card if you belong to a CAMS-affiliated Club to your Temporary Licence Application. Attach also your "Health Statement" letter if required.

Bring this documentation, together with the right amount of <u>cash</u>, with you to the event and present it to our organizing official who will complete the process.

<u>NOTE</u>: There is no electronic money facility at this remote event site – no licence can be issued unless all monies have been paid in full.

If you need to get Temporary Membership of The Vintage Sports Car Club of Western Australia (Inc) then fill in the attached form and follow the instructions. You can do this any time before the end of August before the event, as this nonvoting membership will only apply for the month of September 2019.
